The Nativity School of Harrisburg is offering my son, _____,

I recognize that in accepting this scholarship I accept certain responsibilities which support and affirm the educational philosophy, vision and goals of The Nativity School of Harrisburg found in the Student/Parent/Guardian Handbook, including the School's honor code, which reads: "I will not lie, cheat or steal; I will respect my own physical and spiritual integrity, that of each person at the School, and the integrity of the School itself."

I accept the idea that the School staff will function as my partner in instilling the academic skills, character and spiritual values that will nurture my son's success. Therefore, I will support the School in all their efforts to nurture the discipline and skills, character and intellectual development necessary for my son's total education. Particularly, I will try in my own dealings with the School and otherwise to embody the spirit of the School's honor code (full honesty and respect, non-violence), because I realize that nothing is as effective in encouraging my son's success as a good adult example.

 - Respect for all members of the School community and the School itself;
 - Honest and sincere communication in all dealings;
 - Proper care and respect for books, desks, and all learning materials;

- A sense of purpose.
2. Meet as requested with teachers at the end of the 1st, 2nd, and 3rd marking periods, and with other school officials, to discuss my son's record and progress.
 3. To fully cooperate with completing scholarship applications as identified by the school, providing documentation of household income and other information as needed.
 4. To attend all Parent Meetings.
 5. To make certain that my son attends Summer Programs and other required offerings.
 6. To volunteer my/our time and talent, at least 20 hours per year, to chaperone or participate in School events and projects on behalf of my son.
